2. Nomination papers must be hand delivered to the Returning Officer, Room 1.2, Civic Offices, Euclid Street, Swindon, SN1 2JH on any day from the date of this notice but no later than 4pm on Wednesday, 3 April 2019.
3. If any election is contested the poll will take place on Thursday, 2 May 2019.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Friday 12 April 2019. Applications can be made online: <https://www.gov.uk/register-to-vote>.
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Room 1.2, Civic Offices, Euclid Street, Swindon, SN1 2JH by 5pm on Monday, 15 April 2019.

Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Room 1.2, Civic Offices, Euclid Street, Swindon, SN1 2JH by 5pm on Thursday, 2 May 2019. The physical incapacity must have occurred after 5pm on Wednesday, 24 April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 24 April 2019
