Item 1. Co-option of Cllrs *

For info only

Elections in respect of casual vacancies

If a casual vacancy occurs between now and 5 May 2021 the local council should still notify the vacancy. If a poll is called for by 10 or more parishioners then the poll will be held on 6 May 2021 along with other elections - Regulation 6 (1).

If a poll is not called for, it is NALC's view that the local council can co-opt a replacement councillor.

Item 9. Annual meeting of the Parish Council. *

Regulation 4 - this provides that where an appointment would otherwise be made or is required to be made at an annual meeting of a local authority, the appointment continues until the next annual meeting of the authority or until such time as that authority may determine (Regulation 4 (2)). This would apply to the election of the chairman, the first business at the annual council meeting. Therefore the current chairman will remain in place until an annual meeting is held (possibly next year) unless the council decide to elect a replacement earlier.

The law allows the current Chairman/Vice Chairman to remain in place until May 2020, unless either/both resign from their post, or the council vote to elect a replacement earlier via remote meeting.

Item 11. Annual Parish meeting. (The equivalent of our AGM) *

There is no Annual Parish meeting this year. (The law has been changed to allow this for 2020)
A page will be created on the website and annual reports from all relevant parties displayed.

From NALC: Under Regulation 3 in the briefing it mentions that “Parish meetings are not included within the definition and, as such there is nothing permitting them to meet remotely. In NALC’s view, the current Government guidance means that parish meetings should not take place in person, including the annual meeting of electors.”

Estimated cost of project: £1400, including installation

Matched funding of up to 50% of the total cost, up to a maximum of £700.000.

To design, purchase and install a local history interpretation board in Church Street, adjacent to the entrance to Holy Cross Church.

Design Artwork £ 80
Installation £ 50

All villagers who pass the site, including those who attend services and regular events at Holy Cross Church, will be able to see the board and to learn about the local history of the area.
