**A proposal was made to purchase 2 solar lights from Procure Direct, model DP-005 for the chapel path and ask the handyman to install them. The cost of the units is £611.90 plus VAT. The proposal was seconded and all Cllrs were in favour.** This vote is subject to the Clerk verifying that the batteries can easily be changed, and to also check the cost of new battery units.
